Emails can be lost due to technical errors, such as corrupt PST files, or deleted intentionally or accidentally by users. Users often delete all their mailboxes upon leaving a company. Mailhive can help to eliminate such risks.

If internal access did take place, this will be automatically logged and immediately visible to the customer.
